**RELEASE AND TERMINATION
OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

THIS RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of February 4, 2022 (this “Release”), is made by GUGGENHEIM CREDIT SERVICES, LLC, a Delaware limited liability company, acting in its capacity as collateral agent (in such capacity, the “Collateral Agent”) under that certain Trademark Security Agreement, dated as of December 21, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”), by COLLEGE AVENUE STUDENT LOANS, LLC, a Delaware limited liability company (the “Grantor”) in favor of the Collateral Agent. Capitalized terms used herein without definition are used as defined in the Trademark Security Agreement

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on January 3, 2019 at reel 6516, frame 0641, the Grantor granted to the Collateral Agent on behalf of the Secured Parties a Lien on and security interest in and to, all of the Grantor’s right, title and interest in, to and under its owned or thereafter acquired Trademark Collateral, including those Trademarks set forth on the attached Schedule I;

WHEREAS, the rights under the Trademark Security Agreement were assigned to the Collateral Agent pursuant to that certain Assignment of Security Interest in Trademark Collateral, dated as of June 19, 2019 (the “Trademark Assignment”), which was recorded in the records of the United States Patent and Trademark Office on July 22, 2019 at reel 6699, frame 0749;

WHEREAS, pursuant to that certain Payoff Letter, dated as of February 4, 2022, by and among the Grantor, the other signatories party thereto and the Collateral Agent, the Grantor has requested that the Collateral Agent, and the Collateral Agent has agreed to, (a) release any and all security interests it may have in the Trademark Collateral pursuant to the Trademark Security Agreement or Trademark Assignment and (b) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the Liens and security interest created under the Trademark Security Agreement in the Trademark Collateral, (b) release and relinquish its security interest in the Trademark Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Collateral Agent in the Trademark Collateral. The Collateral Agent agrees, or authorizes the Grantors, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantors to evidence the release and termination of the Collateral Agent’s security interests in the Trademark Collateral.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
