This Assignment is deemed to be executed and delivered within the State of Tennessee, and it is the intention of the parties that it shall be construed, interpreted and applied in accordance with the laws of the State of Tennessee without regard to its conflict of law principles.

Assignor covenants that upon Assignee's request, Assignor shall promptly provide Assignee with all pertinent facts and documents relating to the Marks as may be known and

accessible to Assignor, and will testify, at Assignee's expense, as to the same in any cancellation or litigation related thereto, and Assignor will promptly execute and deliver to Assignee or its legal representative all papers, instruments, or affidavits required to perfect Assignee's title to the Marks and to maintain and enforce the Marks, which may be necessary or desirable to carry out the purposes hereof.
