INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AND ASSUMPTION AGREEMENT (“Assignment”), effective as of August 25, 2020 (“Effective Date”), is by and between Exide Technologies, LLC, a limited liability company organized and existing under the laws of Delaware (“Seller” or “Assignor”), and Element Resources DE LLC, a limited liability company organized and existing under the laws of Delaware (“Element”), Motrex LLC, a limited liability company organized and existing under the laws of Delaware (“Motrex”) and Stryten Manufacturing LLC, a limited liability company organized and existing under the laws of Delaware (“Stryten”) (Element, Motrex and Stryten are each an “Assignee” and collectively the “Assignees”, and Assignor and Assignees are each, a “Party” and, together, the “Parties”).

WHEREAS, pursuant to that certain Stock and Asset Purchase Agreement, dated as of July 27, 2020, by and between Seller, Battery BidCo LLC, a limited liability company organized and existing under the laws of Delaware (“Buyer”) and Atlas Capital Resources III LP, a limited partnership organized and existing under the laws of Delaware (as amended, supplemented or otherwise modified, the “Purchase Agreement”), Seller has agreed to sell, or cause Assignor to sell, and Buyer has agreed to purchase from Assignor, all of Assignor’s right, title and interest in, to, and under the Transferred Assets, in each case, on the terms and subject to the conditions set forth in the Purchase Agreement. Capitalized terms used but not otherwise defined herein shall have the meaning ascribed to them in the Purchase Agreement;

WHEREAS, as required in the Purchase Agreement, Assignor hereby desires to sell, convey, assign, transfer, and deliver all Business Intellectual Property and Business Technology (collectively, the “Assigned IP”) to Assignees, as set forth below, including, without limitation, the Business Intellectual Property and Business Technology set forth on Exhibit A, Exhibit B and Exhibit C hereto, including, without limitation, Schedule C-1 and Schedule C-2 thereto; and

WHEREAS, Assignees desire to purchase, acquire and accept delivery of the Assigned IP from Assignor as set forth herein, which Assigned IP shall be acquired by Assignees in connection with Buyer’s acquisition of the Transferred Equity Interests pursuant to the terms of the Purchase Agreement.

NOW, THEREFORE, in consideration of one dollar (U.S. \$1.00) and for other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, and intending to be legally bound hereby, the Parties agree as follows:

1. Assignment of Intellectual Property. Assignor hereby conveys, sells, assigns and transfers:
 - (a) to Element its entire worldwide right, title and interest in and to all “ELEMENT” trademarks and service marks set forth on Exhibit A and all unregistered Intellectual Property Rights included in the Business Intellectual Property and Business Technology primarily relating to the operation of the lead recycling business of the Business (collectively, the “Element Assigned IP”), together with the ongoing and existing business of Assignor to which the Element Assigned IP pertains (solely as set forth in the Purchase Agreement) and any and all goodwill connected with and symbolized by the Element Assigned IP, the same to be held and enjoyed by Element for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal

representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, as assignee of Assignor's entire right, title and interest therein, including, without limitation, all rights in and to all fees, income, royalties, damages and payments now or hereafter due or payable with respect thereto, all causes of action (whether in law or in equity) with respect thereto, and the right to sue, counterclaim, and recover damages and other remedies for past, present and future infringement, misappropriation, dilution or other violation of the rights assigned or to be assigned to Element under this Assignment;

(b) to Motrex its entire worldwide right, title and interest in and to the Software set forth on Exhibit B and all unregistered Intellectual Property Rights included in the Business Intellectual Property and Business Technology primarily relating to such Software (collectively, the "Motrex Assigned IP"), together with the ongoing and existing business of Assignor to which the Motrex Assigned IP pertains (solely as set forth in the Purchase Agreement) and any and all goodwill connected with and symbolized by the Motrex Assigned IP, the same to be held and enjoyed by Motrex for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, as assignee of Assignor's entire right, title and interest therein, including, without limitation, all rights in and to all fees, income, royalties, damages and payments now or hereafter due or payable with respect thereto, all causes of action (whether in law or in equity) with respect thereto, and the right to sue, counterclaim, and recover damages and other remedies for past, present and future infringement, misappropriation, dilution or other violation of the rights assigned or to be assigned to Motrex under this Assignment; and

(c) to Stryten its entire worldwide right, title and interest in and to all other Business Intellectual Property and Business Technology, including, without limitation, the Business Intellectual Property and Business Technology set forth on Exhibit C, Schedule C-1 and Schedule C-2 hereto (the "Stryten Assigned IP"), together with the ongoing and existing business of Assignor to which the Stryten Assigned IP pertains (solely as set forth in the Purchase Agreement) and any and all goodwill connected with and symbolized by the Stryten Assigned IP, the same to be held and enjoyed by Stryten for its own use and enjoyment and the use and enjoyment of its successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, as assignee of Assignor's entire right, title and interest therein, including, without limitation, all rights in and to all fees, income, royalties, damages and payments now or hereafter due or payable with respect thereto, all causes of action (whether in law or in equity) with respect thereto, and the right to sue, counterclaim, and recover damages and other remedies for past, present and future infringement, misappropriation, dilution or other violation of the rights assigned or to be assigned to Stryten under this Assignment.

2. Binding Agreement. This Assignment shall be binding upon and inure to the benefit of the Parties and their respective permitted successors and assigns. It is understood that any finding of invalidity of one assignment as effected hereby shall not affect the assignment of other Assigned IP.
3. Severability. If any term or provision of this Agreement is held invalid, illegal or unenforceable in any respect under any applicable Law, as a matter of public policy or on any other grounds, the validity, legality and enforceability of all other terms and provisions of this Agreement will not in any way be affected or impaired. If the final judgment of a court of competent jurisdiction or other Government Authority declares that any term or provision hereof is invalid, illegal or unenforceable,

the Parties agree that the court making such determination will have the power to reduce the scope, duration, area or applicability of the term or provision, to delete specific words or phrases, or to replace any invalid, illegal or unenforceable term or provision with a term or provision that is valid, legal and enforceable and that comes closest to expressing the intention of the invalid, illegal or unenforceable term or provision.


4. Amendments. This Agreement may be amended, restated, supplemented or otherwise modified, only by written agreement duly executed by each Party.
5. Further Assurances. Assignor shall execute and deliver such documents, and take such other action, as shall be reasonably requested by any Assignee to carry out the transactions contemplated by this Assignment, and shall take such reasonable actions as may be necessary or appropriate to record, memorialize or make effective the assignments of the Assigned IP contemplated hereby as may be reasonably requested by any Assignee, and to vest and perfect in such Assignee such right, title, and interest in and to the Element Assigned IP, the Motrex Assigned IP or the Stryten Assigned IP, as applicable, as sold, assigned and transferred to such Assignee hereunder.
6. Recordations. Assignor hereby authorizes and requests the officials of the United States Copyright Office and the United States Patent and Trademark Office, and the corresponding entities or agencies in any applicable foreign jurisdiction, to record (a) Element as assignee and owner of the entire right, title and interest in, to and under the Element Assigned IP, (b) Motrex as assignee and owner of the entire right, title and interest in, to and under the Motrex Assigned IP and (c) Stryten as assignee and owner of the entire right, title and interest in, to and under the Stryten Assigned IP.
7. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which when taken together shall constitute one and the same instrument. Facsimiles, e-mail transmission of .pdf signatures or other electronic copies of signatures shall be deemed to be originals.
8. Governing Law. This Agreement will be exclusively governed by and construed and enforced in accordance with the internal Laws of the State of Delaware, without giving effect to any Law or rule that would cause the Laws of any jurisdiction other than the State of Delaware to be applied.
9. No Third-Party Beneficiaries. Nothing in this Agreement shall create or be deemed to create any third-party beneficiary rights in any Person not a party hereto, including any Affiliates of any Party.
10. Entire Agreement. This Agreement, the Purchase Agreement and the other Transaction Agreements (and all exhibits and schedules hereto and thereto) collectively constitute and contain the entire agreement and understanding of the Parties with respect to the subject matter hereof and thereof and supersede all prior negotiations, correspondence, understandings, agreements and Contracts, whether written or oral, among the Parties respecting the subject matter hereof and thereof.
