RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS

This RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS ("Release"), effective as of September 3, 2021, given by **MANUFACTURERS AND TRADERS TRUST COMPANY**, a national banking association, with an address at One M&T Plaza, Buffalo, NY 14240, as Administrative Agent ("Agent") to **ELECTROCHEM COMMERCIAL POWER DELAWARE, INC.**, a Delaware Corporation ("Grantor"), as follows:

W I T N E S S E T H

WHEREAS, the Grantor executed that Credit Agreement, dated as of May 22, 2007 (the "Credit Agreement") and granted to the Agent a security interest in the Collateral, including the United States trademark registrations and applications set forth on Schedule A attached hereto (the "Trademarks") to secure the Secured Obligations (as defined in the Credit Agreement);

WHEREAS, in furtherance of the Credit Agreement, the Grantor executed a Grant of Security Interest, dated January 31, 2008 (the "Trademark Security Agreement"), which was recorded by the U.S. Patent and Trademark Office on February 6, 2008, at Reel 3714 and Frame 0034;

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Trademarks to the Grantor and to terminate the encumbrance created by the Trademark Security Agreement and the Security Agreement in respect of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, without recourse or warranty, the Agent hereby terminates, releases, cancels, relinquishes and discharges the security interest in the Trademarks created by the Trademark Security Agreement and the Security Agreement and reassigns all right, title and interest it has in the Trademark to the Grantor.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE GRANTOR'S AND THE ADMINISTRATIVE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
