ASSIGNMENT OF TRADEMARK

(b) Assignor is the sole and exclusive owner of the entire and unencumbered right, title, and interest in and to the Trademark, free and clear of all liens, charges, and encumbrances;

(c) To the best of Assignor's knowledge, there are no infringement actions pending or threatened alleging that the Trademark or the use thereof infringes any trademarks or other rights held by third parties, nor has there been any final decision adverse to Assignor's claim of ownership of the Trademark;

(d) Neither the Trademark nor any right to the use thereof is subject to any subsisting licenses; and

(e) Assignor has the unqualified right to enter into and fully perform this Assignment.

3. Governing Law. This Assignment shall be governed by and construed in accordance with the internal laws of the State of New York without regard to conflict of laws principles and, to the extent applicable, the laws of the United States.
