TRADEMARK ASSIGNMENT

This Trademark Assignment, effective as of February 7, 2022 (this “**Trademark Assignment**”), is entered into by and between Joachim A. Gloschat, an individual (“**Assignor**”), and Stable Step LLC, an Ohio limited liability company (“**Assignee**”).

WHEREAS, Assignor is the owner of all right, title, benefit, and interest in the trademark set forth in the attached Schedule A (the “**Purchased Mark**”);

WHEREAS, Assignee wishes to acquire from Assignor, and Assignor wishes to transfer to Assignee, all of Assignor’s right, title, benefit, and interest in, to, and under the Purchased Mark;

WHEREAS, Assignor, Assignee, and DRHYS Holdings, LLC f/k/a Doctor Hoy’s, LLC, an Arizona limited liability company (“**Seller**”) have entered into that certain Asset Purchase Agreement of even date herewith (the “**Purchase Agreement**”), pursuant to which Assignee is acquiring certain assets of Seller as set forth in the Purchase Agreement, and Assignor is required to assign the Purchased Mark to Assignee;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which the parties hereby acknowledge, the parties, intending to be legally bound, hereto agree as follows:

Assignor hereby sells, assigns, transfers, conveys, delivers, and sets over to Assignee Assignor’s entire and undivided right, title, benefit, and interest, whether now existing or hereafter acquired, in, to, and under the Purchased Mars, together with all the associated goodwill of its business symbolized by the Purchased Mark, and all applications and registrations of the Purchased Mark, as well as all rights to injunctive relief, damages and profits, due or accrued, arising out of all causes of action, past, present and future, pertaining to the Purchased Mark, including infringement of the Purchased Mark, or other violations, or injury to the said goodwill, and the right to sue, either at law or in equity, and recover the same in Assignee’s own name.

Assignor covenants and agrees to do all acts and take such further action, including execute and deliver, or cause to be executed and delivered, and acknowledge such additional documents, agreements, and instruments as Assignee may reasonably request evidencing the sale, assignment, transfer, conveyance, delivery, and set over to Assignee of the Purchased Mark.

This Trademark Assignment shall be binding upon and inure to the benefit of the parties hereto, and their permitted successors, heirs, and assigns.

This Trademark Assignment may be executed in one or more counterparts, each of which shall be deemed to be an original, and all of which together shall constitute one and the same instrument. Any signature to this Trademark Assignment delivered via facsimile, electronic mail, in .pdf format, or other means of electronic transmission shall be deemed an original for all purposes.

The recitals set forth above are incorporated herein by reference into the terms of this Trademark Assignment.


