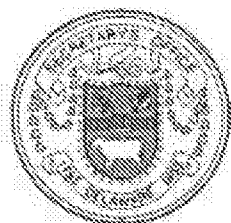

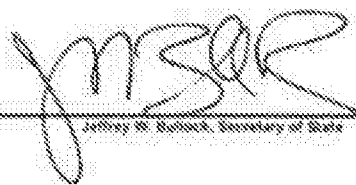

The corporation, United States Soccer Federation Foundation, Inc., organized and existing under the laws of the State of Delaware, hereby certifies as follows:

(1) That at a meeting a vote of the members of the governing body was taken for and against the amendment to the Certificate of Incorporation, said Amendment being as follows:

Pursuant to Section 242 of the General Corporation Law of the State of Delaware, the undersigned, the Authorized Officer of the United States Soccer Federation Foundation, Inc. (the "Corporation"), a non-stock, non-profit corporation duly organized in Delaware under the same name on May 14, 1991 and existing under General Corporation Law of the State of Delaware, does hereby certify that the following resolution was submitted to and approved by the Board of Directors in accordance with Section 242 of the General Corporation Law of the State of Delaware.

RESOLVED, that the Amended and Restated Certificate of Incorporation, as amended, of the Corporation, a non-stock, non-profit corporation incorporated as the United States Soccer Federation Foundation, Inc. under the laws of the State of Delaware on May 14, 1991, be and hereby is amended and Article I is hereby restated in its entirety to read as follows:

**Article I**  
**NAME**

The name of the corporation is UNITED STATES SOCCER FOUNDATION, INC. (the "Corporation").

(2) That said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
