## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of December 29, 2021 (this "Release") is made by Comerica Bank (the "Secured Party"), under the Agreement (Trademark) dated as of April 7, 2020 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and between the Secured Party and Mintie, LLC (the "Debtor") and recorded May 11, 2020 in the records of the United States Patent and Trademark Office at Trademark Reel 6935, Frame 0796. Unless otherwise defined herein, any capitalized term used herein shall have the meaning given to it in the Security Agreement. Pursuant to the Security Agreement, the Debtor mortgaged, pledged, and hypothecated to the Secured Party, and granted to the Secured Party a security interest in the Trademark Collateral, including but not limited to the trademarks listed on attached Exhibit A (the "Security Interest").

The Secured Party now wishes to release and terminate the Security Interest in the Trademark Collateral.

THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby agrees as follows:

1. The Secured Party hereby irrevocably releases, discharges, cancels, and terminates the Security Interest in the Trademark Collateral, and all of the Secured Party's right, title, and interest with respect thereto.
2. The Secured Party authorizes and requests that the Commissioner of Trademarks of the United States Patent and Trademark Office record this Release.
