NOTICE OF RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of February 10, 2022, is made by SILICON VALLEY BANK, a California corporation (the "Bank"), in favor of PLACEIQ, INC., a Delaware corporation (the "Grantor"). Capitalized terms not defined herein have the meanings set forth in the IP Security Agreements.

WITNESSETH:

WHEREAS, pursuant to those certain Intellectual Property Security Agreements described on Annex I attached hereto (the "IP Security Agreements"), the Grantor granted to the Bank, a security interest in all of its right, title and interest in, to and under the Intellectual Property Collateral, including the trademark registrations and applications and issued patents and patent applications listed on Annex II hereto (collectively, the "Intellectual Property"); and

WHEREAS, the Bank wishes to release the security interest and provide a document suitable for recording in the United States Patent and Trademark office and other applicable filing office(s), domestic and foreign, for purposes of recording the release, relinquishment and discharge of its security interest in the Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Bank hereby agrees as follows:

The Bank, without recourse, representation or warranty and at the Grantor's sole cost and expense, hereby terminates, cancels, releases, relinquishes and discharges, in its entirety, for the benefit of the Grantor and its successors and assigns, its security interest in and to the Intellectual Property, the IP Security Agreements and any and all right, title and interest of the Bank in and to the Intellectual Property and the IP Security Agreements shall hereby be terminated, cancelled, released, relinquished and discharged. The Bank hereby authorizes the Grantor and its successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and other applicable filing office(s), domestic and foreign, at the sole expense of the Grantor, to evidence and effectuate the release and termination of the Bank's security interest in the Intellectual Property.
