**TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is dated as of February 10, 2022, and made by JPMORGAN CHASE BANK, N.A., as collateral agent (the “Grantee”).

WHEREAS, pursuant to (i) the First Lien Guarantee and Collateral Agreement, dated as of April 8, 2005, as amended and restated as of April 7, 2016, as further amended and restated as of April 9, 2020 and as further amended and restated as of June 7, 2021 (as so amended and restated and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among THE GOODYEAR TIRE & RUBBER COMPANY, an Ohio corporation (the “Grantor”), the subsidiaries of the Grantor identified as grantors and guarantors therein, and the Grantee, (ii) the Patent and Trademark Security Agreement, dated as of May 11, 2005, between, among others, the Grantor and the Grantee (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “2005 Security Agreement”) and (iii) the IP Security Agreement, dated as of April 14, 2016, between the Grantor and the Grantee (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “2016 Security Agreement”, and, together with the Collateral Agreement and the 2005 Security Agreement, the “Security Agreements”), a security interest was granted by Grantor to Grantee in certain Specified Trademark Collateral (as defined below);

WHEREAS, (i) the 2005 Security Agreement was recorded with the United States Patent and Trademark Office (“USPTO”) on June 6, 2005 at Reel/Frame 003126/0762 and (ii) the 2016 Security Agreement was recorded with the USPTO on April 15, 2016 at Reel/Frame 5771/0890; and

WHEREAS, the Grantor has requested that the Grantee enter into this Release in order to effectuate, evidence and record the release and reassignment to the Grantor of any and all right, title and interest that the Grantee may have in the Specified Trademark Collateral pursuant to the Security Agreements;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Grantee hereby agrees as follows:

1. Definitions.

(a) Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the applicable Security Agreement.

(b) “Specified Trademark Collateral” means, collectively, any and all right, title and interest of the Grantor in (i) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature set forth on Schedule A hereto, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the USPTO or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof (collectively, the “Trademarks”); (ii) all goodwill associated with or symbolized by the Trademarks; and (iii) all other assets, rights and interests that uniquely reflect or embody the goodwill associated with or symbolized by the Trademarks.

2. Release of Security Interests. Grantee, on behalf of itself and the Secured Parties (as defined in the Collateral Agreement) and its and their respective successors, legal

representatives and assigns, hereby (i) irrevocably terminates, releases and discharges the entirety of any and all liens and security interests that it may have pursuant to the Security Agreements in, and all claims that it may have pursuant to the Security Agreements to or in, the Specified Trademark Collateral and (ii) reassigns, transfers and conveys to Grantor all right, title and interest that Grantee may have pursuant to the Security Agreements in the Specified Trademark Collateral. Any right, title or interest that Grantee may have pursuant to the Security Agreements in the Specified Trademark Collateral shall hereby terminate, cease and become void.


3. Further Assurances. Grantee hereby authorizes Grantor or an authorized representative of Grantor to (i) record this Release with the USPTO, (ii) file UCC financing statement amendments with the applicable filing office in order to memorialize the release and discharge of the security interest of Grantee in the Specified Trademark Collateral and/or (iii) otherwise record or file this Release in the applicable governmental office or agency. Grantee further agrees to execute and deliver to Grantor any and all further documents and instruments, and do any and all further acts which Grantor (or its agents or designees) reasonably requests (at Grantor's sole cost and expense) in order to confirm this Release and Grantor's right, title and interest in, to and under the Specified Trademark Collateral.

4. Governing Law. This Release shall be construed in accordance with and governed by the law of the State of New York.
