**TERMINATION AND RELEASE  
OF  
SECURITY INTEREST  
IN TRADEMARKS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release") dated as of February 1, 2022 from **ARES CAPITAL CORPORATION**, as administrative agent for itself and the other Secured Parties (in such capacity, "Administrative Agent"), to Grantors listed on the Schedule I hereof (collectively, jointly and severally, "Grantors" and each individually "Grantor").

WITNESSETH:

WHEREAS, the Grantors executed and delivered that certain Trademark Security Agreement dated January 17, 2014 in favor of the Administrative Agent (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time prior to the date hereof, the "Trademark Agreement");

WHEREAS, pursuant to the Trademark Agreement, each Grantor granted to the Administrative Agent for the benefit of the Secured Parties a security interest in all of such Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks set forth on Exhibit A attached hereto;

WHEREAS, the Trademark Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 17, 2014 at Reel 005196, Frame 0288; and

WHEREAS, the Grantors have requested that the Administrative Agent release and reassign to Grantors its interest in all Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees and acknowledges as follows:


1. Definitions. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Agreement, and this Termination and Release shall be subject to the rules of construction set forth in Trademark Agreement, which rules of construction are incorporated herein by this reference, *mutatis mutandis*.

2. Release of Security Interest. The Administrative Agent hereby releases and reassigns to Grantors any and all liens, security interests, right, title and interest of the Administrative Agent pursuant to the Trademark Agreement in, to and under the Trademark Collateral or any other security interest in the Trademarks granted under the Trademark Agreement, without recourse or representation or warranty, express or implied of any kind.
