Assignor further hereby agrees that Assignee shall have the right to record this instrument of assignment in the United States Patent and Trademark Office so as to establish Assignee as owner of record of the Marks.


Assignor consents to Assignee's use, registration, and any attempts to register the Marks in the United States and hereby provides its specific consent as may be required by the U.S. Patent and Trademark Office for Assignee to file and maintain one or more trademark applications which comprise or include the Marks or any variations thereof, whether in word, stylized or other form. Assignor agrees to execute and deliver any and all additional documents that Assignee or its counsel may reasonably request to effectuate the purposes of this Assignment.

This Assignment shall inure to the benefit of, and be binding upon, the parties and their respective successors and assigns.

This Assignment shall be governed by and construed in accordance with the laws of the State of Nevada, without regard to its conflicts of laws principles.


This Assignment shall be binding upon Assignor and its successors and assigns and shall inure to the benefit of Assignee and its successors and assigns.
