## TRADEMARK ASSIGNMENT AGREEMENT

This **TRADEMARK ASSIGNMENT AGREEMENT** (this "Agreement") is made as of December 20, 2021, by and between Five Points Capital, Inc., a Delaware corporation ("Assignor") and Flagship Oral Surgery Partners, LLC, a Delaware limited liability company ("Assignee"). Assignor and Assignee are collectively referred to herein as the "Parties" and each individually as a "Party".

**WHEREAS**, Assignor adopted the service marks listed on Schedule A hereto for "business management and administrative services, namely, professional staffing and recruiting services; human resources management, procurement in the nature of purchasing equipment, office supplies, business administration consultancy, payroll processing, accounts receivables billing, and marketing" and is the record owner of the United States Trademark Applications to register said marks listed on Schedule A hereto ("Marks"); and

**WHEREAS**, in connection with the transactions contemplated by that certain Securities Purchase Agreement, dated as of December 20, 2021, by and among an affiliate of Assignor, Assignee and the other parties named therein (the "Purchase Agreement"), Assignor has agreed to assign the Marks to Assignee; and

**WHEREAS**, Assignor desires to assign Assignor's entire right, title and interest in, to and under the Marks, any and all registrations and applications for registration thereof, to the Assignee pursuant to the terms of this Agreement.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor does hereby assign, transfer and set over unto Assignee, its successors, legal representatives and assigns, the Assignor's entire right, title and interest in, to and under each Mark, the goodwill symbolized thereby, the business associated therewith, which business is ongoing and existing, the United States Trademark Applications for registration thereof, and all rights derived from or associated with use of each Mark by Assignor, including the right to sue for and receive all damages accruing from past, present, and future infringement of said Marks.

2. Assignor hereby covenants, warrants, and represents that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

3. At the reasonable request of Assignee and at Assignee's expense, Assignor will execute and deliver and will cause to be executed and delivered such instruments of transfer, conveyance, assignment, and confirmation, and will take such actions as Assignee may reasonably deem necessary, to effectively transfer, contribute, assign, and deliver to Assignee all of Assignor's rights, title, and interests in and to the Marks.

4. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Delaware, without giving effect to the conflict of laws rules thereof.




