RELEASE OF SECURITY INTEREST IN TRADEMARK

This RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") is made as of the date hereof by H.I.G. CAPITAL, LLC, in its capacity as administrative agent under the Trademark Security Agreement referred to below (the "Administrative Agent"), in favor of DOCUPHASE, LLC, a Delaware limited liability company (the "Company").

WHEREAS, the Company is the owner of that certain "Clearwater Payments" trademark, as registered with the United States Patent and Trademark Office under registration #4969747 (the "Mark").

WHEREAS, FPT Operating Company, LLC ("FPT") entered into that certain Notice of Grant of Security Interest in Trademarks dated December 23, 2016, with the Administrative Agent (the "Trademark Security Agreement"), notice of which was recorded on December 23, 2016, at the United States Patent and Trademark Office at Reel 5950, Frame 0755.

WHEREAS, capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, FPT granted the Administrative Agent, under the terms of the Trademark Security Agreement, a continuing security interest in favor of the Administrative Agent in the Mark, and all goodwill of the business connected with the use of, and symbolized by, the Mark.

WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in the Mark as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, the Administrative Agent hereby releases and terminates any and all liens and security interests of the Administrative Agent in the Mark, including all goodwill of the business connected with the use of, and symbolized by, the Mark.

This Release is a release of the Administrative Agent's security interest in the Mark only, and it shall in no manner release, affect or impair the Administrative Agent's lien on or security interest in any other property of FPT, including without limitation, any other trademark described in the Trademark Security Agreement.
