ARTICLES OF MERGER

(a Louisiana state-chartered bank)

with and into

FIRST HORIZON BANK
(a Tennessee state-chartered bank)

Pursuant to Chapter 21 of the Tennessee
Business Corporation Act and Chapter 45 of the Tennessee Banking Act

The undersigned parties submit these Articles of Merger:

FIRST: The names of the constituent banks of the merger are First Horizon Bank, a Tennessee state-chartered bank, and IBERIABANK, a Louisiana state-chartered bank that is authorized to conduct business in the State of Tennessee (collectively, the "Constituent Banks").

SECOND: The name of the surviving bank is "First Horizon Bank", a Tennessee state-chartered bank (the "Surviving Bank"). The mailing address and principal place of business of the Surviving Bank is 165 Madison Avenue, Memphis, Tennessee 38103.

THIRD: The merger shall be effective 12:01 AM Central Time on July 2, 2020 (the "Effective Time").

FOURTH: The charter of First Horizon Bank in effect immediately prior to the Effective Time shall be the charter of the Surviving Bank.

FIFTH: An Agreement and Plan of Merger (the "Merger Agreement"), dated as of June 29, 2020 and attached as **Annex A**, has been approved, adopted, certified, executed and acknowledged by each of the Constituent Banks. The Board of Directors of the Surviving Bank adopted the Merger Agreement on December 17, 2019. The Merger Agreement was approved on June 29, 2020 by First Horizon National Corporation, the sole voting shareholder of the Surviving Bank.


SIXTH: The Merger Agreement and performance of its terms were duly authorized by all action required by the laws under which IBERIABANK was organized and by its charter or organic documents.
