RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 15, 2022 (the “Effective Date”), is made by JPMorgan Chase Bank, N.A., in its capacity as Administrative Agent (the “Administrative Agent”), in favor of the grantor parties identified on the signature page hereto (the “Grantors”).

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of February 11, 2019, by and among the Administrative Agent, the Grantors and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the “Security Agreement”), and pursuant to the Trademark Security Agreement dated February 11, 2019 and recorded with the United States Patent and Trademark Office on February 11, 2019 at Reel/Frame 6557/0254 (the “Trademark Security Agreement”), each Grantor pledged and granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in and to all of its rights, title and interest in, to and under all of the following Collateral (excluding any and all Excluded Assets) of each Grantor: (a) registered United States Trademarks and Trademark applications of the Grantors, including those listed on Schedule I attached hereto and all proceeds and products of the foregoing (collectively, the “Trademark Collateral”);

WHEREAS, pursuant to that certain Payoff Letter, dated as of February 15, 2022, by and among the Grantors, the other signatories party thereto and the Administrative Agent, the Grantors have requested that the Administrative Agent, and the Administrative Agent has agreed to, among other things, (a) release any and all security interests it may have in the Trademark Collateral pursuant to the Security Agreement and Trademark Security Agreement, (b) the reassignment to the Grantors of any and all right, title and interest that the Administrative Agent and the Secured Parties may have in the Trademark Collateral, and (c) provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, cancellation, termination, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.

2. Release. The Administrative Agent, for itself and for the benefit of the Secured Parties, without representation or warranty of any kind, hereby releases, discharges, terminates, relinquishes and cancels, in its entirety, for the benefit of the Grantors, and their successors and assigns, all of its security interest in, to and under the Trademark Collateral, including the trademark registrations and applications set forth in Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreement. If and to the extent that the Administrative Agent has acquired any right, title or interest in and to the Trademark Collateral under the Security Agreement and Trademark Security Agreement, the Administrative Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantors.


3. Termination. The Administrative Agent, without representation or warranty of any kind, terminates and cancels the Security Agreement and Trademark Security Agreement.

4. Further Assurances. The Administrative Agent hereby authorizes the Grantors to make filings with the United States Patent and Trademark Office and agrees to take all further actions, and provide to the Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors, at the Grantors' sole cost and expense, to evidence the release and termination of the Administrative Agent's security interest in the Trademark Collateral and to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of the state of New York, without regard to conflicts of law or choice of law principles.
