**TERMINATION OF SECURITY INTEREST
IN TRADEMARKS**

THIS TERMINATION OF SECURITY INTEREST IN TRADEMARKS is made effective as of February 11, 2022 by CIBC Bank USA, as administrative agent (the “Administrative Agent”).

Administrative Agent agrees to provide Company with any information and additional authorization necessary to effect the release of Administrative Agent’s security interest in the Trademark Collateral.
