**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN  
TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of February 16, 2022 is made by Eclipse Business Capital LLC (f/k/a Encina Business Credit, LLC), as agent for certain lenders (in such capacity, including any successors thereto, the "Grantee").

WITNESSETH:

WHEREAS, pursuant to the Loan and Security Agreement, dated as of May 7, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Loan Agreement"), by and between, among others, Comag Marketing Group, LLC, a Delaware limited liability company (the "Grantor"), the Lenders from time to time party thereto and the Grantee, the Lenders have severally agreed to make extensions of credit to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Notice of Grant of Security Interest in Trademarks, dated as of May 7, 2021 (the "Trademark Security Agreement"), a lien on and security interest (collectively, the "Security Interest") was granted by the Grantor to the Grantee in certain collateral, including the Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on May 11, 2021 at Reel/Frame 7287/0808.

WHEREAS, the Grantee now desires to terminate and release the entirety of its Security Interest in the Collateral, including those trademarks listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Grantee hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the Trademark Security Agreement or the Loan Agreement, as applicable.
2. Release of Security Interest. The Grantee, without representation, warranty or recourse, hereby terminates, releases and discharges any and all Security Interest in the Collateral, and any right, title or interest of the Grantee in such Collateral shall hereby cease and become void.
3. Recordation. The Grantee authorizes the Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Grantor's expense.
