TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of February 17, 2022, by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as administrative agent under the Micronics Filtration, LLC term loan facility (the “Administrative Agent”) in favor of **MICRONICS FILTRATION, LLC** (as successor in interest to Micronics, Inc.), a Delaware limited liability company with an address at 200 West Road, Portsmouth, NH 03801 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into the Notice of Grant of Security Interest in Trademarks dated March 28, 2013 (as amended, modified, restated or supplemented from time to time, the “IP Security Agreement”) with the Administrative Agent, notice of which was recorded on March 28, 2013 at the United States Patent and Trademark Office at Reel 4993, Frame 0759.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the IP Security Agreement.

WHEREAS, the Grantor granted the Administrative Agent, under the terms of the IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of such Grantor’s right, title and interest in, to and under the Collateral, including without limitation the Trademarks listed in Schedule A (collectively, the “Trademark Collateral”).

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in the Trademark Collateral, including the Trademarks listed in Schedule A as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, including the Trademarks listed in Schedule A hereto, and assigns, transfers and conveys to Grantors the Security Interest.
