In the event Assignee chooses to abandon or sell its rights in the Marks, it is agreed that Assignee shall offer to transfer the rights in the Marks to Assignor for the amount paid in this Assignment by written notice delivered to Assignor by electronic mail at aartman@wertacoma.com. If Assignor does not respond to Assignee's offer of transfer within ten (10) days, Assignor will be considered to have rejected Assignee's offer, and Assignee may abandon or sell its rights freely.
