WHEREAS, Assignee wishes to confirm that it acquired and received all of Assignor's rights, title and interest in and to the Trademarks via the In-Kind Contribution Agreement; and

NOW, THEREFORE, in consideration of the mutual promises set forth within this Trademark Assignment Agreement, and the original In-Kind Contribution Agreement between the parties, and for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

1. Assignor confirms that it assigned and hereby memorializes the assignment to Assignee of all of its rights, title and interest in and to the Trademarks via the In-Kind Contribution Agreement, including common law rights of those Trademarks, together with the good will the business symbolized thereby and appurtenant thereto.

2. The Assignor and Assignee agree that this Trademark Assignment Agreement may be executed in one or more counterparts, each of which together shall constitute one and the same original assignment document, and any electronically scanned or facsimile transmitted signature shall




be deemed to be an original signature, and a true copy of this Trademark Assignment Agreement shall have the same legal effect as an original copy.
