## TRADEMARK ASSIGNMENT

This Trademark Assignment (the “Assignment”) dated as of February 7, 2022 is made by Al-Jon Manufacturing, L.L.C., a Delaware limited liability company (“Assignor”), in favor of C&C Manufacturing, LLC, an Iowa limited liability company (“Assignee”). Assignor and Assignee are sometimes referred to herein as a “Party” and together as the “Parties”.

WHEREAS, Assignor is the owner of the Assigned Trademarks (as defined below); and

WHEREAS, RFC Al-Jon Lender, LLC, a Colorado limited liability company (“RFC Al-Jon Lender”), hereby executes and delivers this Assignment on behalf of Assignor and RFC Al-Jon Lender.

NOW, THEREFORE, in consideration of the agreements set forth in this Assignment, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties, intending to be legally bound hereby, agree as follows:

1. Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee hereby accepts, all of Assignor’s right, title, and interest in and to the following (the “Assigned Trademarks”), together with any common law rights and the goodwill of the business connected with the use of, and symbolized by, the Assigned Trademarks:
  - a. The trademark registrations and trademark applications set forth on Schedule A hereto and all issuances, extensions and renewals thereof;
  - b. All rights of any kind whatsoever of Assignor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and

conventions and otherwise throughout the world;

- c. Any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and
- d. Any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including all rights to and claims for damages, restitution and injunctive and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Recordation and Further Actions. Assignor hereby authorizes the Commissioner for Trademarks in the United States Patent and Trademark Office and the officials of corresponding entities or agencies in any applicable jurisdictions to record and register this Assignment upon request by Assignee. Following the date hereof, upon Assignee's reasonable request, Assignor shall take such steps and actions, and provide such cooperation and assistance to Assignee and its successors, assigns and legal representatives, including the execution and delivery of any affidavits, declarations, oaths, exhibits, assignments, powers of attorney, or other documents, as may be reasonably necessary to effect, evidence or perfect the assignment of the Assigned Trademarks to Assignee, or any assignee or successor thereto.
3. Governing Law. This Assignment and any claim, controversy, dispute or cause of action (whether in contract, tort or otherwise) based upon, arising out of or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed

in accordance with, the laws of the United States and the State of Colorado, without giving effect to any choice or conflict of law provision or rule (whether of the State of Colorado or any other jurisdiction).



