ARTICLES OF CONVERSION OF
UNIVERSAL CONSULTING SERVICES, INC.

Pursuant to Title 13.1, Chapter 9, Article 12.2 of the Code of Virginia, the undersigned, on behalf of the corporation set forth below, states as follows:

Article I

The name of the Virginia corporation immediately before the filing of these articles of conversion is Universal Consulting Services, Inc. (the "Company"). The corporation shall convert to a Virginia limited liability company and its name shall be Universal Consulting Services, LLC (the "Virginia LLC").

Article II

The converting corporation was originally incorporated on December 14, 2000 as a corporation with the name Universal Consulting Services, Inc.

Article III

The plan of conversion, pursuant to § 13.1-722.10 of the Code of Virginia, is set forth as follows:

A. The full text of the articles of organization of the resulting limited liability company as they will be in effect upon consummation of the conversion is attached hereto as Exhibit A.


B. The manner and basis of converting or exchanging outstanding shares of stock of the Company into limited liability company interests of the Virginia LLC is as follows: each share of capital stock of the Company issued and outstanding immediately prior to the filing of these Articles of Conversion shall be converted into 0.025% of the limited liability company interests of the Virginia LLC, such that, as a result of the foregoing, 100% of the outstanding capitalization of the Virginia LLC shall consist of such limited liability company interests.

Article IV

A. The plan of conversion was adopted by the board of directors and was duly approved by the shareholders on January 14, 2022 in the manner required by Chapter 9 of Title 13.1 of the Code of Virginia and by the articles of incorporation.

Article I The limited liability company's name:

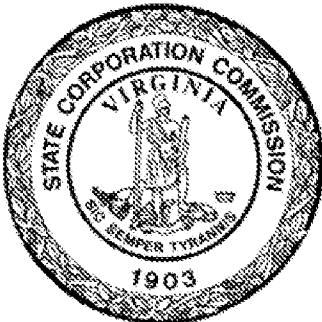
