RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of this 11th day of February, 2022, by BMO HARRIS BANK, N.A., in its capacity as Administrative Agent for itself and the other Lender Parties (in such capacity, the “Agent”), in favor of COASTAL SUNBELT PRODUCE, LLC, a Maryland limited liability company and EAST COAST FRESH, LLC, a Maryland limited liability company (each a “Grantor” and, collectively, the “Grantors”). Unless otherwise defined herein, capitalized terms used in this Release shall have the meanings assigned to such terms in the Security Agreement (as defined below).

WHEREAS, the Grantors and the Agent entered into that certain Grant of a Security Interest - Trademarks, dated as of May 29, 2015, which was recorded with the United States Patent and Trademark Office on May 31, 2015 at Reel/Fame 5526/0662 (the “Trademark Security Agreement”);

WHEREAS, pursuant to (i) that certain Pledge and Security Agreement, dated as of May 29, 2015 (as amended, restated, supplemented, or otherwise modified from time to time, the “Security Agreement”), entered into by each Grantor in favor of the Agent, and (ii) the Trademark Security Agreement, each Grantor pledged and granted to the Agent, a security interest in all of such Grantor’s right, title and interest in, to and under the Trademarks listed on Schedule A attached hereto, together with the goodwill of the business symbolized by the Trademarks and the right to receive all proceeds of any of the foregoing and any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violation thereof (the “Trademark Collateral”); and


WHEREAS, the Agent has agreed to terminate, cancel, release and discharge its security interest in the Trademark Collateral.

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby (i) absolutely, unconditionally and irrevocably terminates, cancels, releases and discharges the security interest in the Trademark Collateral and any and all other liens and security interests that the Agent or its successors and assigns may have in, to or on the Trademark Collateral and (ii) terminates and cancels the Trademark Security Agreement.
2. The Agent represents and warrants that it has full authority to execute and deliver this Release.
3. This Release shall be governed by and construed and interpreted in accordance with the laws of the State of New York.
4. This Release may not be supplemented, altered or modified in any manner except by a writing signed by all parties hereto. This Release shall be binding upon the Agent’s successors and assigns and is made in favor of and for the benefit of each Grantor and its successors and assigns.

IN WITNESS WHEREOF, the Agent has caused this Release to be executed by its authorized officer as of the date of this Release.
