RELEASE OF SECOND LIEN SECURITY INTEREST

This RELEASE OF SECOND LIEN TRADEMARK AND PATENT SECURITY AGREEMENT (this “Release”), dated as of February 17, 2022, is made by UBS AG, Stamford Branch, as Collateral Agent (in such capacity, the “Collateral Agent”) in favor of The Knot Worldwide Inc. (formerly known as WeddingWire, Inc.), a Delaware corporation, Something Blue, LLC, a Delaware limited liability company, XO Group Inc., a Delaware corporation, WeddingChannel.com, Inc., a Delaware corporation, The Bump Media, Inc., a Delaware corporation, Gigmasters.com Incorporated, a Delaware corporation, and Couple LLC, a Delaware limited liability company (collectively, the “Grantors”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the Pledge and Security Agreement (as defined below) or the Trademark and Patent Security Agreements (as defined below), as applicable.

WHEREAS, IDO US Acquiror, Corp., a Delaware corporation (“Holdings”), The Knot Worldwide Inc. (formerly known as WeddingWire, Inc.), a Delaware corporation (the “Borrower”), the other Grantors, the Collateral Agent and the other parties thereto executed and delivered that certain Second Lien Pledge and Security Agreement, dated as of December 21, 2018, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Pledge and Security Agreement”);

WHEREAS, pursuant to the Pledge and Security Agreement, the Grantors, as applicable, executed and delivered (i) that certain Second Lien Trademark and Patent Security Agreement, dated as of December 21, 2018, in favor of the Collateral Agent on behalf of the Secured Parties (the “December 2018 Trademark and Patent Security Agreement”), which granted (x) a security interest in patents of certain Grantors, which security interest was recorded with the United States Patent and Trademark Office on January 7, 2019 at Reel/Frame 048432/0278, and (y) a security interest in trademarks of certain Grantors, which security interest was recorded with the United States Patent and Trademark Office on January 7, 2019 at Reel/Frame 6518/0051, and (ii) that certain Second Lien Trademark and Patent Security Agreement, dated as of May 11, 2020, in favor of the Collateral Agent on behalf of the Secured Parties (the “May 2020 Trademark and Patent Security Agreement” and together with the December 2018 Trademark and Patent Security Agreement, the “Trademark and Patent Security Agreements”), which granted (x) a security interest in patents of certain Grantors, which security interest was recorded with the United States Patent and Trademark Office on May 11, 2020 at Reel/Frame 052626/0478, and (y) a security interest in trademarks of certain Grantors, which security interest was recorded with the United States Patent and Trademark Office on May 11, 2020 at Reel/Frame 6935/0951;

WHEREAS, pursuant to the Pledge and Security Agreement and the Trademark and Patent Security Agreements, the Grantors granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest (the “Security Interest”) in the Trademark and Patent Collateral;

WHEREAS, the Trademark and Patent Collateral included (i) the patents and patent applications listed on Schedule A hereto and all rights corresponding thereto throughout the world, all reissues, divisions, continuations, continuations-in-part, extensions and reexaminations of any of the foregoing, the right to sue for past, present and future infringements of any of the foregoing

and all proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages and proceeds of suit and (ii) the trademarks and trademark applications, listed on Schedule B hereto and all common-law rights related thereto and all rights corresponding thereto throughout the world, all of the goodwill of the business connected with the use of and symbolized by the foregoing, all extensions and renewals of the foregoing, the right to sue for past, present and future infringements or dilution of any of the foregoing or for any injury to goodwill, and all proceeds of the foregoing, including, without limitation, licenses, royalties, income, payments, claims, damages, and proceeds of suit (collectively, the “Released Trademark and Patent Collateral”); and

WHEREAS, pursuant to the payoff letter dated as of the date hereof, among Holdings, the Borrower, the Grantors, the Collateral Agent and the other parties thereto, the Collateral Agent has agreed to take actions reasonably necessary to release and terminate any and all security interests it may have in the Released Trademark and Patent Collateral pursuant to the Loan Documents, and the Grantors hereby request a specific release of the Security Interest granted and recorded against the Released Trademark and Patent Collateral.

NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark and Patent Security Agreements, (ii) releases any and all Security Interests in the Released Trademark and Patent Collateral which had been granted to it by the Grantors pursuant to the Pledge and Security Agreement and the Trademark and Patent Security Agreements, without recourse to, or representation or warranty by, the Collateral Agent and (iii) re-assigns to the Grantors, any right, title or interest the Collateral Agent or any Secured Parties may have in, to or under the Released Trademark and Patent Collateral, together with the goodwill of the business symbolized thereby, in each case pursuant to the Trademark and Patent Security Agreements and the other Loan Documents. For the avoidance of doubt, except as expressly set forth above, nothing herein shall affect any other security interest granted by Grantors or any other grantors to the Collateral Agent or any Secured Party.

The execution and/or delivery of this Release and any further documents and the actions associated with the release of the Security Interest and the Released Trademark and Patent Collateral referred to in this Release by the Collateral Agent are made without recourse to or warranty by the Collateral Agent or any Secured Party.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.


