NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS

Dated as of February 22, 2022

United States Patent and Trademark Office

Ladies and Gentlemen:

Please be advised that, pursuant to that certain Collateral Agreement, dated as of April 7, 2021 (as the same may be amended, restated, amended and restated, supplemented, extended, and/or otherwise modified in writing from time to time, the "Agreement"), by and among the Grantors party thereto, and MUFG UNION BANK, N.A., as collateral agent (the "Collateral Agent") for the Secured Parties referenced therein, J2 GLOBAL VENTURES LLC (the "New Grantor") has, in accordance with the terms of the Agreement, granted a continuing security interest in, and a right to set off against the trademarks and trademark applications identified on Schedule I hereto to the Collateral Agent, for the benefit of the Secured Parties.

Notwithstanding the foregoing, pursuant to the terms of the Agreement, no security interest has been granted with respect to any United States federal "intent to use" trademark or service mark applications to the extent that, and solely during the period that, the grant of a security interest therein would impair the validity or enforceability or render void or result in the cancellation of, any registration issued as a result of such "intent to use" trademark or service mark application under applicable law; provided that upon the submission and acceptance by the United States Patent and Trademark Office of an amendment to allege or a verified statement of use pursuant to 15 U.S.C. Section 1060, such "intent to use" trademark or service mark application shall no longer be excluded.

The New Grantor and the Collateral Agent, on behalf of the Secured Parties, hereby acknowledge and agree that the security interest in the foregoing trademarks and trademark applications: (i) may only be terminated in accordance with the terms of the Agreement; (ii) is not to be construed as an assignment of any trademark or trademark application; and (iii) the New Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the foregoing made and granted hereby are more fully set forth in the Agreement, the terms and provisions of which are incorporated herein by reference as if fully set forth herein and that in the event that any provision of this notice is deemed to conflict with the Agreement, the provisions of the Agreement shall control. This Notice of Grant of Security Interest in Trademarks may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract.


