TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is made effective as of March 12, 2018, from **THE FIRE WITHIN (NASHUA), LLC**, an New Hampshire limited liability company having an address at 449 Amherst Street, Nashua, NH 03063 ("ASSIGNOR"), to **TONY NASER**, an individual having an address at 6 Apollo Way, Salem, NH 03079 ("ASSIGNEE"):

WHEREAS, ASSIGNOR is the owner of the trademark CRUSH PIZZA (the "Mark") and of United States Trademark Registration Numbers 4900581 and 4917370 for the mark used in connection with restaurant services and pizza, respectively, together with the goodwill of the business symbolized thereby in connection with the goods and services on which the Mark is used;

WHEREAS, ASSIGNEE is the sole member of the ASSIGNOR and, in connection with the dissolution of the ASSIGNOR, the ASSIGNOR has conveyed, transferred, assigned, delivered, and contributed to ASSIGNEE all of its right, title, and interest in and to the Mark by virtue of a distribution of substantially all of the assets of the ASSIGNOR's business to the ASSIGNEE;

WHEREAS, this Assignment is intended to document said transfer with respect to the Mark for purposes of recording said change in ownership with the United States Patent and Trademark Office;

NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Mark, together with (1) the goodwill of the business relating to the goods and services in respect upon which the Mark is used and for which they are registered: (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark: and (3) all rights to sue for past, present and future infringements or misappropriations of the Mark.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Mark.
