**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "Release"), dated as of February 4, 2022, is made by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as collateral agent (in such capacity, the "Collateral Agent"), under the Security Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement, the Purchase Agreement or the Security Agreement, as applicable).

**WHEREAS**, (i) Delaware North Companies, Incorporated, a Delaware corporation (the "Company"), the Lenders party thereto and JPMorgan Chase Bank, N.A., as Administrative Agent, are party to that certain Second Amended and Restated Credit Agreement, dated as of January 14, 2011 (as the same has since been amended, restated, amended and restated, supplemented, or otherwise modified from time to time, the "Credit Agreement"), (ii) the Company and the Purchasers party thereto are party to that certain Note Purchase Agreement, dated as of June 1, 2000 (as amended, restated, supplemented or otherwise modified from time to time, the "Purchase Agreement"), and (iii) the Company, certain Subsidiaries of the Company and the Collateral Agent are party to that certain Pledge and Security Agreement, dated as of June 30, 2020 (as may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement");

**WHEREAS**, pursuant to the Security Agreement and those agreements described on Annex I attached hereto (collectively, the "IP Security Agreements"), the Grantors granted security interests to the Collateral Agent in certain intellectual property owned by the Grantors (the "IP Collateral"); and

**WHEREAS**, the IP Security Agreements were recorded in the United States Patent and Trademark Office or the United States Copyright Office, as applicable, on the dates and on the reels/frames or volume/document no., as applicable, set forth on Annex I attached hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby irrevocably **RELEASES**, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in the IP Collateral, and the Collateral Agent hereby reassigns any and all such right, title and interest (if any) that the Collateral Agent may have in, to and under the IP Collateral to the relevant Grantor.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
