### TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of February 18, 2022, and made by PNC BANK, NATIONAL ASSOCIATION (together with its successors and assigns in such capacity, the "Collateral Agent"), to SMARSH INC., a New York corporation, MOBILEGUARD, LLC, a Delaware limited liability company, f/k/a MOBILEGUARD INC., a Nevada corporation, and SKYWALKER INTERMEDIATE HOLDINGS, INC., a Delaware corporation (each a "Grantor" and collectively, the "Grantors").

The Collateral Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in all of the Grantors' right, title and interest of every kind and nature in the Trademark Collateral, including those Trademarks and Licenses referred to on <u>Exhibit A</u> hereto and reassigns to the person or persons legally entitled thereto all right, title and interest of the Collateral Agent (if any), in, to and under the Trademark Collateral
