ACKNOWLEDGMENT OF SECURITY INTEREST IN TRADEMARKS

February 22, 2022

WHEREAS, UNIVERSAL ATLANTIC SYSTEMS, LLC, a Delaware limited liability company ("Grantor"), has adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the annexed Schedule 1, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, Grantor has entered into a Guaranty and Collateral Agreement, dated as of February 22, 2022, by and among Grantor, Administrative Agent (as defined below), and certain other loan parties from time to time party thereto (as amended, restated, supplemented or otherwise modified from time to time in accordance with its terms, the "Guaranty and Collateral Agreement"), in favor of CIBC Bank USA, as administrative agent for certain lenders (in such capacity, "Administrative Agent"); and

WHEREAS, pursuant to the Guaranty and Collateral Agreement, Grantor has granted to Administrative Agent a continuing security interest in all right, title and interest of Grantor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Collateral"), to secure the payment, performance and observance of the Secured Obligations (as defined in the Guaranty and Collateral Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor does hereby grant to Administrative Agent for the benefit of certain lenders a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Administrative Agent with respect to the Collateral are more fully set forth in the Guaranty and Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


