**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 21, 2021 (“Release”), is made by FIDUS INVESTMENT CORPORATION, a Maryland corporation, as Collateral Agent (“Agent”) in favor of SES FOAM, LLC, a Delaware limited liability company formerly known as SES ACQUISITION SUB I, LLC (“Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated September 8, 2016, by and between Agent and Grantor (the “Trademark Security Agreement”), which was recorded at the United States Patent and Trademark Office (“USPTO”) on September 8, 2016 at Reel 5872 and Frame 0841 (“Notice”), Grantor granted to Agent a security interest in any and all of Grantor’s right, title, and interest in and to certain Trademark Collateral, including the Trademarks listed on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

SECTION 2. Termination and Release. Agent, without representation, warranty, or recourse, hereby irrevocably:

(a) terminates, cancels, discharges, and releases the security interest in all of its right, title and interest in and to the Trademarks and the use thereof, together with all Trademark Intellectual Property Licenses, income, royalties, damages and other payments, proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, granted pursuant to the Trademark Security Agreement; and

(b) authorizes the Grantor, and any of their designees, to file this Release with the USPTO and/or any other applicable governmental office or agency to evidence the release and termination of the security interest in the Trademarks contemplated hereby. Agent agrees to execute and deliver to the Grantor all other instruments and other documents as the Grantor may reasonably request to release the security interest in the Trademarks which had been granted under the Notice, in each case, at the sole expense of the Grantor.
