**ASSIGNMENT OF
TRADEMARK SECURITY AGREEMENTS**

This ASSIGNMENT OF TRADEMARK SECURITY AGREEMENTS (the “Assignment”) dated as of February 24, 2022, is made by MORGAN STANLEY CAPITAL ADMINISTRATORS, INC., as assignor (the “Assignor”) in favor of WILMINGTON TRUST, NATIONAL ASSOCIATION, as assignee (the “Assignee”). Capitalized terms used but not defined herein shall have the meanings given to them in the Trademark Security Agreements (as defined below) or the Guaranty and Security Agreement (as defined below) unless otherwise specified herein.

WHEREAS, pursuant to that certain Credit Agreement, dated as of November 5, 2019 (as amended, restated, supplemented or otherwise modified from time to time), by and among SELECTQUOTE, INC. (the “Borrower”), each other Person from time to time party thereto that is designated as a Credit Party, MORGAN STANLEY CAPITAL ADMINISTRATORS, INC., as a Lender and as Administrative Agent (in such capacity, the “Administrative Agent”) for the Lenders, UMB BANK, N.A., a national banking association, as a Lender and Revolver Agent for itself and the Revolving Lenders (in such capacity, the “Revolver Agent”), and the Lenders and L/C Issuers party thereto from time to time (the “Credit Agreement”), the Borrower and certain other Grantors party thereto entered into a Guaranty and Security Agreement, dated as of November 5, 2019, with Assignor, as Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”);

WHEREAS, pursuant to the Guaranty and Security Agreement, SELECTQUOTE INSURANCE SERVICES, as a Grantor, executed and delivered a Trademark Security Agreement, dated November 5, 2019, in favor of the Assignor (“Insurance Services Trademark Security Agreement”), which was recorded in the United States Patent and Trademark Office on November 5, 2019 at Reel/Frame 6788/0161;

WHEREAS, pursuant to the Guaranty and Security Agreement, SIMPLE MEDS, LLC, as a Grantor, executed and delivered a Trademark Security Agreement, dated November 2, 2021, in favor of the Assignor (the “Simple Meds Trademark Security Agreement,” and, together with the Insurance Services Trademark Security Agreement, the “Trademark Security Agreements”), which was recorded in the United States Patent and Trademark Office on November 2, 2021 at Reel/Frame 7481/0508;

WHEREAS, pursuant to the Guaranty and Security Agreement and the Trademark Security Agreements, the Grantors granted to the Assignor (as Administrative Agent), for the ratable benefit of the Secured Parties, a security interest (the “Security Interest”) in all of such Grantor’s right title and interest in and to the Collateral, including the trademark registrations and applications set forth in Schedule 1 hereto;

WHEREAS, pursuant to that certain Successor Agent Agreement, dated February 24, 2022, by and among Assignor, Assignee, certain of the Lenders under the Credit Agreement, the Revolver Agent, the Borrower and the other Credit Parties under the Credit Agreement, (i) Assignor resigned as Administrative Agent and Assignee was appointed the successor Administrative Agent, (ii) Assignor transferred, assigned, granted and conveyed unto Assignee, as

Administrative Agent, all of its right, title and interest in and to the Guaranty and Security Agreement, the Trademark Security Agreements, and the security interest in the Collateral; and

WHEREAS, Assignor and Assignee wish to confirm and record the assignment of the Trademark Security Agreements and the security interest in the Collateral by Assignor to Assignee.

NOW THEREFORE, in consideration of the foregoing premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby transfers, assigns, grants and conveys unto Assignee, and Assignee hereby assumes, all of Assignor's right, title and interest in and to the Trademark Security Agreements and the security interest in the Trademarks listed on Schedule 1. This Assignment may be executed by the parties to this Assignment in any number of separate counterparts (including by facsimile or PDF signatures), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.


