ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

2. Article I of the Articles of Incorporation of the Corporation is amended to read in its entirety as follows:

ARTICLE I

NAME

The name of the Corporation is Hooker Furnishings Corporation.

3. The foregoing amendment to the Corporation's Articles of Incorporation was adopted on April 7, 2021.



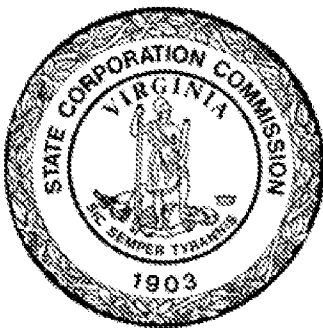
