## **RELEASE OF TRADEMARK SECURITY**

RELEASE, dated as of February 23, 2022 granted by Barclays Bank PLC, as security agent and security trustee for the Secured Parties (as defined in the Facility Agreement referred to in the Mortgage Debenture, dated as of June 1, 2018 (as amended, restated, supplemented or otherwise modified from time to time (the "Security Agreement"))) (in such capacity together with its successors and permitted assigns (the "Security Agent") in favor of Keywords International Limited an Irish corporation ("Grantor").

### **W I T N E S S E T H :**

WHEREAS, Grantor is party to the Security Agreement among the Grantor and the Security Agent pursuant to which the Grantor granted to the Security Agent for the benefit of the Secured Parties a security interest in certain of Grantor's assets, including the U.S. Trademark Registrations identified in Schedule A hereto, including all the goodwill associated therewith (the "Trademarks");

WHEREAS, Grantor and the Security Agent have entered into a Global Deed of Release, dated as of December 23, 2021 (the "Deed of Release"), pursuant to which Security Agent has agreed to release the security interest with respect to the U.S. Trademark Registrations identified on Schedule A attached hereto (the "Released Trademarks"); and

WHEREAS, in connection with such Deed of Release, Grantors have requested, and the Security Agent has agreed to the release of the security interest in the Released Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Security Agent does hereby release and discharge the security interest in the Released Trademarks, without recourse, representation or warranty of any kind and at the sole cost and expense of Grantors. For the avoidance of doubt, nothing in this Release shall be deemed a representation or warranty with respect to the Released Trademarks, Grantor's or Security Agent's right, title or interest therein or thereto, or the release granted herein, and none of Grantors or any other third party shall have any recourse against Security Agent in any way in connection with the Released Trademarks or this Release.
