**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 17, 2022 (the “Effective Date”), is made by BMO HARRIS BANK N.A., a national banking association (formerly known as Harris N.A.) (the “Secured Party”), in favor of RUDOLPH FOODS COMPANY, INC., an Ohio corporation (the “Debtor”).

WHEREAS, the Debtor executed and delivered a Trademark Collateral Agreement, dated as of December 23, 2008 (the “Rudolph Trademark Collateral Agreement”) to the Secured Party for recordal with the United States Patent and Trademark Office;

WHEREAS, WHITEFEATHER FOODS, INC., an Ohio corporation (“Whitefeather”) executed and delivered a Trademark Collateral Agreement, dated as of December 23, 2008 (the “Whitefeather Trademark Collateral Agreement”) and together with the Rudolph Trademark Collateral Agreement, collectively, the “Trademark Collateral Agreements” and individually, each a “Trademark Collateral Agreement”) to the Secured Party for recordal with the United States Patent and Trademark Office;

WHEREAS, (i) the Rudolph Trademark Collateral Agreement was recorded with the United States Patent and Trademark Office on December 31, 2008 at Reel 003911 Frame 0817; and (ii) the Whitefeather Trademark Collateral Agreement was recorded with the United States Patent and Trademark Office on December 31, 2008 at Reel 003911 Frame 0805;

WHEREAS, Whitefeather was merged with and into the Debtor, with the Debtor as the surviving entity, pursuant to a Certificate of Merger filed with the Ohio Secretary of State on January 4, 2013, and such Certificate of Merger was recorded with the United States Patent and Trademark Office on November 7, 2014 at Reel 005396 Frame 0316;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. Release. The Secured Party hereby releases, discharges, terminates and cancels all of its security interest in and to the property referenced in the Trademark Collateral Agreements, including the trademark registrations and applications set forth on Schedule I attached hereto, arising under the Trademark Security Agreements.


2. Termination. The Secured Party, without representation or warranty of any kind, terminates and cancels each Trademark Security Agreement.

3. Further Assurances. The Secured Party agrees to take all further actions, and provide to the Debtor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Debtor, at the Debtor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of Illinois.
