TRADEMARK ASSIGNMENT
(nunc pro tunc)

This TRADEMARK ASSIGNMENT (“**Assignment**”) is made effective as of August 3, 2021, by NW Wine Company, LLC, an Oregon limited liability company (“**Assignor**”), in favor of Casparian Holdings, LLC, an Oregon limited liability company (“**Assignee**”), the purchaser of certain assets of Assignor pursuant to that certain Asset Purchase Agreement dated as of September 4, 2020 (the “**Asset Purchase Agreement**”).

WHEREAS, Under the terms of the Asset Purchase Agreement, Assignor has sold, assigned, conveyed and transferred to Assignee, among other assets, Assignor’s entire right, title and interest in and throughout the world in and to the trademarks listed on Exhibit A attached hereto (the “**Marks**”), including any common law rights that may exist and are associated therewith, and has agreed to execute and deliver this Assignment for recording with the United States Patent and Trademark Office.

NOW, THEREFORE, Assignor agrees as follows:

1. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee all of Assignor’s right, title, and interest in and to the Marks, together with the goodwill of the business connected therewith, all income, royalties, damages or payments now or hereafter due or payable with respect to any and all of the foregoing, and any and all claims and causes of action for damages or payments by reason of infringement or unauthorized use of the Marks, along with the right to sue for past infringements and collect same for Assignee’s sole use and enjoyment.
2. Assignor does hereby authorize the Commissioner for Trademarks in the United States Patent & Trademark Office to record the Marks and title thereto as the property of Assignee.
3. This Assignment is entered into pursuant to the Asset Purchase Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Marks. The representations, warranties, covenants, agreements, and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.
