SERVICEMARK REASSIGNMENT

Assignor hereby assigns, transfers, sells and conveys to the Assignee, clear of all liens and encumbrances, all right, title and interest in and to the servicemarks in the United States covered by federal servicemark Reg. No. 2,808, 318 upon THE VIRGINIA COMPANY, and servicemark Reg. No.3,346,968, upon THE VIRGINIA COMPANY + Design, including, without limitation, all goodwill associated with and symbolized by the marks; and the right to sue or otherwise recover from any and all past, present and future infringements and misappropriations or unfair competitions involving the servicemarks, and Assignee hereby obtains all income, royalties, damages, and other payments now or hereafter due and payable with respect to the marks; and all other rights accruing from the marks, together in each case with the goodwill of the business connected with the use of, and symbolized by, the servicemarks.
2. The consideration for this reassignment of the two identified servicemarks is One Dollar (\$1.00), and other valuable considerations receipt of which is hereby acknowledged by the Assignor.

3. Assignee acknowledges that Assignor makes no representation or warranty with respect to the assigned servicemarks being conveyed hereby.
4. This Assignment shall bind and inure to the benefit of the parties and their respective successors and assigns. Assignor represents and warrants that at this time it is the title holder of the identified servicemarks, and it is the recorded owner of all right and title to all of the marks, and that consent of or release from any third party is not necessary for the reassignment of the foregoing to Assignee.
