**TERMINATION AND RELEASE OF
ASSIGNMENT FOR SECURITY - TRADEMARKS**

THIS TERMINATION AND RELEASE OF ASSIGNMENT FOR SECURITY - TRADEMARKS (this "Termination"), is dated as of October 27, 2021, and made by **CIT NORTHBRIDGE CREDIT LLC**, in its capacity as Agent under the below-defined Security Agreement ("Grantee") to **ARKOS FIELD SERVICES, LP**, a Texas limited partnership ("Grantor").

WHEREAS, pursuant to that certain Assignment for Security - Trademarks, dated as of February 8, 2018 made by Grantor in favor of Grantee (as amended, restated, amended and restated, extended, supplemented and/or otherwise modified from time to time, the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the United States Trademark and Patent Office ("USPTO") at Reel 0640, Frame 6381 on May 2, 2018; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Trademark", as used herein, shall have the meaning set forth in the Security Agreement and shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule A hereto.
2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark.
