TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST --
TRADEMARKS

This TERMINATION AND RELEASE OF GRANT OF A SECURITY INTEREST -- TRADEMARKS ("Termination and Release") dated as of February 23, 2022, is from MORGAN STANLEY SENIOR FUNDING, INC., as Administrative agent and Collateral agent (in such capacities, the "Administrative Agent") to ABB/CON-CISE OPTICAL GROUP LLC, LENSICO LLC and OPTICAL DISTRIBUTOR GROUP LLC (collectively, the "Trademark Grantors"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Security Agreement or the Trademark Security Agreement, as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of June 15, 2016 (as amended, restated, supplemented or otherwise modified from time to time (the "Security Agreement"), among the Trademark Grantors, the other grantors party thereto and the Administrative Agent, the Trademark Grantors executed and delivered that certain Trademark Security Agreement, dated as of June 15, 2016 (as amended, restated, supplemented or otherwise modified from time to time (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office at Reel 005824, Frame 0386, pursuant to which the Trademark Grantors granted a security interest to the Administrative Agent, for the benefit of the Secured Parties, in the Trademark Collateral, including the Trademarks listed on Schedule A hereto and made a part hereof.

WHEREAS, the Administrative Agent now desires to terminate and release its security interest in the Trademark Collateral.


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent, for itself and for the benefit of and on behalf of the Secured Parties, does hereby state as follows:

1. Administrative Agent hereby terminates, cancels and releases any and all of its security interest in all of Trademark Grantors' right, title and interest in and to the Trademark Collateral.
2. Administrative Agent shall take all further actions, and provide to each of the Trademark Grantors and their respective successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Trademark Grantors to more fully and effectively effectuate the purposes of this releases.
