**TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (PATENTS
AND TRADEMARKS)**

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST (PATENTS AND TRADEMARKS) (this "Termination"), is dated as of January 26, 2022, and made by DEERFIELD MGMT, L.P. (the "Grantee"), to NEOS THERAPEUTICS, INC., a Delaware corporation (the "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of October 2, 2019, made by the Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the IP Collateral (as defined in the Security Agreement);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on October 7, 2019 at Reel/Frame 006764/0875;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the IP Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. Capitalized terms used, but not defined, herein shall have the meaning given such terms in the Security Agreement.



Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the IP Collateral, including but not limited to all intellectual property listed on Exhibit A hereto, and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the IP Collateral.
