## RELEASE OF TRADEMARK SECURITY INTEREST

This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made and granted by Landmark Community Bank, a Tennessee state-chartered bank, in its capacity as collateral agent (the "Collateral Agent").

WHEREAS, ClearPoint Neuro, Inc. (formerly known as MRI Interventions, Inc. and SurgiVision, Inc.), a Delaware corporation (the "Company") and the Collateral Agent, in its capacity as collateral agent for the ratable benefit of the registered holders of the Company's Junior Secured Promissory Notes due 2020 (the "Holders"), entered into that certain Junior Security Agreement, dated as of November 5, 2010, as amended by that certain First Amendment to Junior Security Agreement dated as of April 5, 2011, as further amended by that certain Second Amendment to Junior Security Agreement dated October 14, 2011, as further amended by that certain Third Amendment to Junior Security Agreement dated March 25, 2014, and as further amended by that certain Fourth Amendment to Junior Security Agreement dated January 27, 2020 (as amended, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Company has granted to the Collateral Agent, on behalf of the Holders, a third-priority security interest in, to and under the Trademark Collateral (as defined below), among other collateral; and

WHEREAS, the Company has requested that the Collateral Agent enter into this Release in order to accomplish and evidence the release of any and all right, title and interest the Collateral Agent may have in the Trademark Collateral pursuant to the Security Agreement.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby states as follows:


1. Definition. The term "Trademark Collateral," as used herein, shall mean all of the Company's right, title and interest of every kind and nature in the registered trademarks and trademark applications listed in Schedule I hereto.

2. Release of Security Interest. The Collateral Agent terminates, releases and discharges its security interest in and to the Trademark Collateral and all other right, title, and interest in and to the Trademark Collateral and reassigns to the Company any and all such right, title and interest that it may have in the Trademark Collateral. Secured Party hereby authorizes Company, or Company's authorized representative, to record this Release with the United States Patent and Trademark Office.




