**RELEASE OF SECURITY INTEREST**

This RELEASE OF SECURITY INTEREST, effective as of March 3, 2022, is made by COMERICA BANK pursuant to the Security Agreement defined below (in such capacity, "Secured Party").

WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on Trademark Reel/Frame 4910/0499 on November 30, 2012.


WHEREAS, the Secured Party no longer claims an interest in the Collateral.
