UNITED STATES TRADEMARK ASSIGNMENT


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Assignor hereby irrevocably assigns, grants, conveys and transfers to Assignee all right, title and interest in and to the Trademarks in perpetuity together with the goodwill of the business symbolized by the Trademarks including that portion of the business to which the Trademarks pertain, the exclusive right to apply for and receive registrations of the Trademarks throughout the United States its territories and possessions, and the exclusive right to enforce the Trademarks, including to sue and recover damages for past, present and future infringements. Assignor authorizes the Assignee to record the transfer of the registrations. This assignment agreement will inure to the benefit of and be binding on the parties’ successors and assigns.


