**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 3, 2022, is made by **U.S. BANK NATIONAL ASSOCIATION**, a national banking association, in its capacity as Agent (as defined in the Security Agreement (as defined below)), in favor of **FTS International Services, LLC**, a Texas limited liability company (the "Grantor").

WHEREAS, pursuant to that certain (i) Indenture, dated as of June 1, 2015 (as amended, amended and restated, extended, supplemented or otherwise modified from time to time, the "Indenture"), by and among the Grantor as issuer, the guarantors party thereto and the Agent as trustee, (ii) Security Agreement, dated as of June 1, 2015, among the guarantors party thereto and the Agent and (iii) Trademark Security Agreement, dated as of June 1, 2015 (as amended, amended and restated, extended, supplemented or otherwise modified from time to time, the "IP Security Agreement") among the Grantor and U.S. Bank National Association as the Agent, the Grantor granted to the Agent, for the benefit of the Secured Parties, a security interest in the Grantor's right, title and interest in and to certain trademarks and service mark registrations and applications identified in Schedule A attached hereto (such scheduled trademarks and service mark registrations and applications, the "Trademarks"); capitalized terms used but not defined herein shall have the meanings assigned to such terms in the Indenture, the Security Agreement or the IP Security Agreement, as applicable;

WHEREAS, the Grantor has requested that the Agent release and reassign its interest in the Trademarks to the Grantor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby agrees as follows:

The Agent, on behalf of the Secured Parties, hereby:

1. Discharges, and releases the lien on and security interest in and to the Trademarks and/or any goodwill associated with the Trademarks, without recourse or representation or warranty, express or implied of any kind;


2. Reassigns to the Grantor any and all liens, security interests, right, title and interest of the Agent pursuant to the Security Agreement in the Trademarks, without recourse or representation or warranty, express or implied, of any kind; and

3. Authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

4. This release shall be governed by, and construed in accordance with, the laws of the State of New York. This release may be executed in counterparts (and by different parties hereto in different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page of this release by telecopier or other electronic transmission (PDF or TIFF format) shall be effective as delivery of a manually executed counterpart of this release. Any signature to this release may be delivered by facsimile, electronic mail (including pdf) or any electronic signature complying with the U.S. federal ESIGN Act of 2000 or the New York Electronic Signature and Records Act or other transmission method and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes to the fullest extent permitted by applicable law. Each of the parties hereto represents and warrants to the other parties hereto that it has the corporate capacity and authority to execute this release through electronic means and there are no restrictions for doing so in such party's constitutive documents.
