RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of March 7, 2022 (this "Release"), by Montage Capital II, L.P. ("Lender"), in favor of Kenandy, Inc., a Delaware corporation ("Company"), with its principal place of business located at 5000 Executive Parkway, #150, San Ramon, CA 94583.

Recitals

WHEREAS, Company granted to Lender a security interest in the intellectual property of Company, including without limitation the patent and trademark items listed on Exhibits A and B attached hereto (collectively, the "Intellectual Property"), under an Intellectual Property Security Agreement dated as of January 29, 2018 (the "Security Agreement") which was recorded with the US Patent and Trademark Office as set forth on the exhibits.

WHEREAS, Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property.

Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby agrees as follows:

- 1. Release. Lender hereby releases, discharges, terminates and cancels all of its security interest in and to the Intellectual Property, including the patent registrations and applications set forth on Exhibit A attached hereto and the trademark registrations and applications set forth on Exhibit B attached hereto, arising under the Security Agreement.
2. Termination. Lender hereby agrees that the Security Agreement is terminated and reassigns to Company, without warranty or recourse, all interest of Lender in the Intellectual Property.
3. Further Assurances. Lender agrees to take all further actions, and provide to the Company and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Company, at the Company's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
4. Binding. This Release shall be binding upon Lender's legal representatives, assigns and successors.
