**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”) is made as of this 8th day of March, 2022, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent (“Agent”), in favor of STYLECRAFT HOME COLLECTION, INC., a Delaware corporation (“Grantor”).

WHEREAS, Grantor entered into a certain Trademark Security Agreement, dated February 3, 2020 with Agent, notice of which was recorded with the United States Patent and Trademark Office on February 3, 2020 at reel/frame 6854/0895 (the “Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WHEREAS, Grantor granted to Agent, under the terms of the Security Agreement, a continuing security interest in favor of Agent, in and to all of its right, title and interest in and to the Trademark Collateral, including without limitation the trademarks listed in Schedule I attached hereto.


WHEREAS, Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent hereby releases, terminates and discharges its security interest in the Trademark Collateral, including the trademarks listed on Schedule I attached hereto and made a part hereof, terminates the Security Agreement and assigns, transfers and conveys to Grantor any right, title or interest, including the security interest, it may have in the Trademark Collateral of Grantor. Grantor, or any successor to Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of Grantor), is hereby authorized to record this Release in the United States Patent and Trademark Office.
