TRADE MARK ASSIGNMENT

**PARTIES:**

- (1) **DIPTYQUE S.A.S.**, a company incorporated in France whose business address is 34, boulevard Saint Germain, F-75005, Paris, France ("ASSIGNOR"); and
- (2) **BYREDO AB**, a company incorporated in Sweden whose business address is Box 3065, SE-103 61, Stockholm, Sweden ("ASSIGNEE")

**RECITALS:**

- A. The ASSIGNOR is the registrant of the trade mark registrations listed in the Schedule (the "TRADE MARKS").
- B. The parties have agreed to execute this Assignment for the purpose of assigning the ASSIGNOR's rights in the TRADE MARKS to the ASSIGNEE and to record the ASSIGNEE's interest in the same.

**OPERATIVE TERMS:**

1. Assignment

In consideration of the sum of £1 (one pound sterling) and other good and valuable consideration (the receipt and sufficiency of which are hereby acknowledged by the ASSIGNOR) the ASSIGNOR hereby assigns to the ASSIGNEE and the ASSIGNEE hereby accepts all the ASSIGNOR's property right title and interest in and to the TRADE MARKS including associated trade mark goodwill and all common law rights in relation to the TRADE MARKS and including the benefit of all priority dates and the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse of or passing off in relation to any of the same, whether past present or future.

2. Authorisation

The ASSIGNOR hereby authorises the ASSIGNEE and the ASSIGNEE's agents to sign all such forms on behalf of the ASSIGNOR as the ASSIGNEE considers appropriate in order to record the TRADE MARKS in the name of the ASSIGNEE.

3. Law

This Assignment shall be governed by and construed and take effect in accordance with English law.
