INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT (this “Assignment”), dated as of November 1, 2021 (“Effective Date”), is by and among ABB Schweiz AG, a corporation organized under the laws of Switzerland (“ABB Schweiz”), ABB Motors and Mechanical Inc., a Missouri corporation (“ABB MMI”), and ABB Asea Brown Boveri Ltd, a corporation organized under the laws of Switzerland (“Seller”), (each an “Assignor” and collectively, the “Assignors”), on the one hand, and RBC Bearings Incorporated, a Delaware corporation (“RBC”), and Dodge Acquisition Co., a Delaware corporation and wholly owned subsidiary of RBC (“Assignee”), on the other hand.

WHEREAS, Seller and RBC entered into a Stock and Asset Purchase Agreement dated as of July 24, 2021 (the “Purchase Agreement”) pursuant to which Seller agreed to, or agreed to cause the applicable member of the Seller Group (as that term is defined in the Purchase Agreement) to, transfer, convey, assign and deliver to Purchaser the Business Intellectual Property (as that term is defined in the Purchase Agreement) set forth on Section 1.1(b) of the Seller Disclosure Schedule to the Purchase Agreement (collectively, the “Transferred IP”);

WHEREAS, RBC has assigned to Assignee RBC’s right to purchase the Transferred IP pursuant to the Purchase Agreement; and

WHEREAS, pursuant to the Purchase Agreement, the Assignors wish to assign to Assignee, and Assignee wishes to acquire from the Assignors, all of the Assignors’ right, title and interest in and to all the Transferred IP.

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth herein and in the Purchase Agreement, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, each party hereto agrees as follows:

1. Assignment. Effective as of the Effective Date, each Assignor hereby assigns to Assignee, all of its right, title and interest in and to all Transferred IP, including all (i) patents, patent applications, invention disclosures and know how, including the patents and patent applications, set forth on Schedule A and any applications that claim priority to any of the patents and patent applications set forth in Schedule A (the “Transferred Patents”), (ii) all trademarks and trademark applications set forth on Schedule B and the goodwill and coexistence and consent agreements associated therewith (the “Transferred Marks”), and (iii) all business internet properties set forth in Schedule C.

2. Recordation. Each of the parties hereto hereby authorizes and requests the United States Patent & Trademark Office and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar) to record, at Assignee’s sole cost and expense, Assignee as the registered owner of the Transferred IP. Assignee shall have the right and sole responsibility (but not the obligation) to record, at Assignee’s sole cost and expense, this Assignment with all applicable governmental authorities and registrars so as to record and perfect its ownership of the Transferred IP.

3. Further Assurances. Each of the parties hereto undertakes to perform all such further acts, execute, transfer and deliver all such further documents, and make all such

further declarations as may reasonably be requested by any other party hereto in order to give full effect to the assignment and transfer of the Transferred IP contemplated in this Assignment from the Assignors to Assignee.

4. Relation to the Purchase Agreement. This Assignment is made pursuant to and subject to the Purchase Agreement. In the event of any conflict or inconsistency between this Assignment and the Purchase Agreement, the Purchase Agreement shall control, except that, in the event of inconsistencies between Section 1.1(b) of the Seller Disclosure Schedule to the Purchase Agreement and Schedules A, B and C hereto, Schedules A, B and C shall control. Except as expressly set forth in the Purchase Agreement, the Assignors make no representations or warranties regarding, and hereby disclaim all representations and warranties, express or implied, regarding, the Transferred IP, including any implied warranties of title (with the exception of the Assignors warranting that the Assignors are fully entitled to undertake the transactions contemplated under this Assignment) or non-infringement. Article 12 of the Purchase Agreement is hereby incorporated *mutatis mutandis*. Any Assignors who are not a party to the Purchase Agreement have entered into this Assignment solely for the purpose of facilitating Seller's obligations under the Purchase Agreement, and are not otherwise undertaking or assuming any obligations under the Purchase Agreement.

5. Miscellaneous. While the Assignors and Assignee are the parties to this Assignment, it is understood that this Assignment also applies to their successors in interest, assigns, licensees and affiliated companies including those established via merger or name change.
