**RELEASE OF SECURITY INTEREST
IN PATENT, TRADEMARK AND COPYRIGHT COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN PATENT, TRADEMARK AND COPYRIGHT COLLATERAL (this “Release”), dated as of November 24, 2021, is made by Morgan Stanley Senior Funding, Inc., in its capacity as administrative agent (the “Administrative Agent”), in favor of (i) ABILITY Network Inc., a Delaware corporation, (ii) Inovalon, Inc., a Delaware corporation and, (iii) Avalere Health LLC, a Maryland limited liability company (each, a “Grantor” and collectively, the “Grantors”), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of April 2, 2018 (as amended, restated, amended and restated, supplemented and restructured or otherwise modified, renewed or replaced from time to time, the “Collateral Agreement”), among the Grantors and the other parties party thereto, in favor of the Administrative Agent, the Grantors granted a security interest in all of the Grantors’ and certain other parties’ right, title, and interest in, to and under certain collateral, including the Patent Collateral, Trademark Collateral and Copyright Collateral (each as defined in the applicable IP Collateral Agreement, as defined below), in favor of the Administrative Agent;

WHEREAS, pursuant to the Collateral Agreement, those certain Patent Security Agreements, Trademark Security Agreements and Copyright Security Agreements listed in Annex I attached hereto (collectively, the “IP Collateral Agreements”) were entered into by a Grantor and the Administrative Agent; and

WHEREAS, the Administrative Agent now desires to terminate and release the IP Collateral Agreements and the entirety of its security interest in the IP Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

1. Definitions. The term “IP Collateral”, as used herein, shall include all of the Grantors’ right, title or interest in, to and under all Patent Collateral, Trademark Collateral and Copyright Collateral, including without limitation all of the patents, patent applications, patent licenses, trademarks, trademark applications, copyrights, and copyrights applications listed on Annex II attached hereto. Capitalized terms used, but not otherwise defined herein, shall have the meanings set forth in the Collateral Agreement or the applicable IP Collateral Agreement, as applicable.

2. Release of Security Interest. The Administrative Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby terminates, cancels, releases, relinquishes, discharges and reassigns to the Grantors, in its entirety, for the benefit of the Grantors and their successors and assigns, its security interest in, to and under the IP Collateral and hereby terminates and releases the IP Collateral Agreements described on Annex I attached hereto. Any and all right, title and interest of the Administrative Agent in, to and under the IP Collateral arising under the Collateral Agreement or the IP Collateral Agreements shall hereby be terminated, cancelled, released, relinquished and discharged and Administrative Agent hereby assigns, transfers and conveys to Grantors any interest in any of the foregoing. The Administrative Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and the United States Copyright Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Administrative Agent’s security interest in the IP Collateral hereunder.



This Release may be executed in counterparts, each of which when so executed shall be deemed to be an original and all of which when taken together shall constitute one and the same instrument. For the avoidance of doubt, the foregoing also applies to any amendment, extension or renewal of this Release.

4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.




