**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Termination and Release”), dated as of March 10, 2022, by Royal Bank of Canada, as administrative agent (in such capacity, the “Administrative Agent”).

WITNESSETH:

WHEREAS, pursuant to certain Intellectual Property Security Agreement, dated as of June 23, 2021 and recorded with the Trademark Division of the United States Patent and Trademark Office on June 23, 2021 at Reel/Frame 7334/0588 (the “IP Security Agreement”), McKissock, LLC, Elite Professional Education, LLC, American School of Real Estate Express, L.L.C., Allied School, LLC, The Institute For Luxury Home Marketing, L.P., Securities Training Corp., American School of Real Estate Express, L.L.C., Real Zona Partners, LLC, Compucram.com LLC, Hondros Learning, LLC, Compucram.com, LLC, Hondros College Pennsylvania, LLC, Hogan School of Real Estate, LLC, Reicon Publishing, LLC, Rocky Mountain Publishing LLC, Bert Rodgers School of Real Estate, LLC, Rockwell Publishing Company, LLC, and Gold Coast Professional Schools, LLC (collectively, the “Grantors”) granted to the Administrative Agent security interest in all of Grantors’ right, title and interest in and to the Collateral (as defined in the IP Security Agreement), including but not limited to the trademarks set forth on Schedule 1 hereto (the “Trademark Collateral”);

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein shall have the meanings set forth in the IP Security Agreement.

2. Release of Security Interest. The Administrative Agent, without representation, warranty or recourse, hereby terminates the IP Security Agreement and terminates, releases, relinquishes, and discharges any and all security interest in the Trademark Collateral, and any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void. To the extent required, the Administrative Agent reassigns to Grantor any and all right, title and interest of any nature whatsoever which it may hold in or to the Copyright Collateral. At the sole expense of Grantor, the Administrative Agent agrees to execute, acknowledge and deliver all such further instruments and documents and to take all such further actions necessary to evidence and carry out the purposes of this Termination and Release.

3. Recordation. The Administrative Agent authorizes each Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at such Grantor’s expense.



The words “execution,” “signed,” “signature” and words of like import in this Termination and Release shall be deemed to include electronic signatures or the keeping of records in electronic form, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature or the use of a

paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act or any other similar state laws based on the Uniform Electronic Transactions Act. This Termination and Release may be delivered by facsimile or other electronic transmission of the relevant signature pages hereof.





